REMOVAL OF SHELL COMPANY STATUS

We respectfully request that OTC Markets Group remove the "shell" designation from the profile of Smokefree Innotec, Inc. (the "Company" or "SFIO").

As defined in Rule 405 under the Securities Act and Rule 12b-2 under the Exchange Act, a shell company is a company with (1) no or nominal operations, and (2) has any one of the following: (i) no or nominal assets, (ii) assets consisting solely of cash and cash equivalents; or (iii) assets consisting of any amount of cash and cash equivalents and nominal other assets.

The Company now has more than nominal operations and more than nominal assets through its ownership of six (6) Australian and New Zealand-based subsidiaries: Epiphany Café Franchise Group, Ardent Bakers, Gorgeous Coffee Co., A+ Electrical, Accord Investment Group and AG Architects - all of which currently have a strong presence in New Zealand and Australia.

SFIO Has More Than Nominal Business Operations Through Subsidiaries' Revenue

The assets of Smokefree Innotec, Inc. (SFIO) were purchased from Agrokings, Inc. in an asset purchase on **August 20, 2021**. Agrokings, Inc. unaudited revenue was **US\$15,853,201** for the period of **January 1 - August 20, 2021**.

SFIO Has More Than Nominal Non-Cash Assets Through Each of Its Subsidiaries

The assets of each company acquired by SFIO are listed below:

- 1. Smokefree Innotec, Inc. has current assets of **US\$3,426,133** of cash, inventory and accounts receivables valued according to Agrokings, Inc. **August 20, 2021** interim balance sheet.
- 2. Smokefree Innotec, Inc. has fixed and non-current assets of **US\$7,034,704** of property, equipment and intangible assets valued according to Agrokings, Inc. **August 20, 2021** interim balance sheet.
- 3. Smokefree Innotec, Inc. has liabilities of **US\$1,829,262** of Accounts Payable, other current liabilities and non-current liabilities valued according to Agrokings, Inc. **August 20, 2021** interim balance sheet.

In consideration of the Company's more than nominal business operations and more than nominal non-cash assets, the Company is not a shell, and we request the OTC Markets Group remove shell status from the Company's profile on OTCMarkets.com.
