ProConcept Marketing Group, Inc. (the "Company" or "PMG") was incorporated in the State of Florida 2006.

ProConcept Marketing Group, Inc. is a publicly traded company engaged in strategic marketing and business management, offering proprietary engagement marketing strategies, talent procurement, and management consulting to major international corporations engaged in a variety of industries.

On April 2, 2021, 9,900,000 shares of the Series A preferred stock were sold to Infinity Group Holdings LLC, an entity controlled by Betty Sytner.

On August 2, 2021, Infinity Group Holdings, LLC sold their 9,900,000 shares of Series A preferred stock to Nathan Puente, resulting in a change of control of the Company.

Basis of presentation

The Company's unaudited financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The accompanying unaudited financial statements reflect all adjustments, consisting of only normal recurring items, which, in the opinion of management, are necessary for a fair statement of the results of operations for the periods shown.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Company to make estimates and judgments that affect the reported amounts of assets and liabilities, revenues and expenses, and related disclosures of contingent assets and liabilities. These estimates and judgments are based on historical information, information that is currently available to the Company and on various other assumptions that the Company believes to be reasonable under the circumstances. shares outstanding at the time of a vote. Each share of Series A is convertible into ten shares of common stock at any time at the option of the holder.

NOTE 5 – RELATED PARTY TRANSACTIONS

During the nine months ended September 30, 2021, Barry Sytner, husband of the former CEO, loaned the Company \$56,771 to pay for general operating expenses. The loan was non-interest bearing and due on demand. As of September 30, 2021. Mr. Sytner chose to forgive the loan in full. The \$56,711 has been credited to paid in capital.
