NOTE 1- NATURE OF OPERATIONS

Nature of Operations

NOTE 2- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

These financial statements are presented in United States dollars and have been prepared in accordance with generally accepted accounting principles in the United States of America.

NOTE 3-STOCKHOLDERS' EQUITY

The company's capitalization is 350,000,000 common shares with a par value of \$.001 per share and 5,000,900 preferred shares with a par value of \$.001.

NOTE 4 – NOTES PAYABLE

\$10,320 issued 04/03/19 to Paul Bajakian for loans to the Company, note is convertible at 50% to market and bears 6% interest rate;

\$12,500 issued 10/08/2019 to James Quinn for a loan to the Company, note is convertible at 50% to market and bears 10% interest rate.

\$82,500 issued 09/13/2021 to Quick Capital LLC for a loan to the Company, note is convertible at the lesser of \$0.07 or 50% to market; and

\$82,500 issued 09/28/2021 to MacRab LLC for a loan to the Company, note is convertible at the lesser of \$0.07 or 50% to market.

NOTE 5 – MATERIAL EVENTS

On December 10, 2020, the Company completed a reverse merger with Dryworld Brands, LLC, whereby the Company acquired 100% interest in Dryworld Brands, LLC in exchange for preferred and common shares of the company.
