ORDERED, that the above name defendants, Epic Worldwide, Alan Tucker, PM Barbee Holdings, Goldwater Group, Energy 101 Consulting LLC, Exuma Capital Inc., JJM Consulting Inc., KCG Americas LLC, National Financial Services, LLC and John Bryan Pike show cause before a motion term of this Court, at Room , United States Courthouse, 500 Pearl Street, in the City, County and State of New York on <u>September 1</u>, 2022, at <u>10:00</u> o'clock in the morning thereof, or as soon thereafter as counsel may be heard, why an order should not

ORDERED that Defendants submit any opposition papers by 12:00 p.m. on August 31, 2022.
