## **CHANGE IN SHELL COMPANY STATUS**

Trustfeed Corp. (the "Company" or "TRFE"), a Nevada corporation, is a publicly quoted issuer on the OTC Markets Group, Inc. (The "OTC Markets") trading platform and is classified as a "Pink Sheets Alternative Reporting under the ticker symbol "TRFE".

The Company has previously been classified as a shell company by OTC Markets ("Shell Company").

*Definition: Rule 12b-2 of the Securities Exchange Act of 1934 (and defined Rule 405 as promulgated under same said Exchange Act section) defines a Shell Company as a company that has: (A) no or nominal operations; and (B) either (1) no or nominal assets; (2) assets consisting solely of cash and cash equivalents; or (3) assets consisting of any amount of cash and cash equivalents and nominal other assets ("Rule 12b-2").*

Effective September 30, 2022, the Company ceased to be a Shell Company. The reasons the Company believes it is no longer a Shell Company are set forth below:

The company provides trusted company and product information with state-of-the-art crawler technology. Machine learning and Artificial intelligence tools are the techniques that Trustfeed uses in its constant endeavor to source trustworthy information. Trustfeed enables businesses to create brand awareness, get endorsement of their products and anticipate a feedback loop for product improvement. Trustfeed is open for subscribers and the company is selling data which are the two main source of revenue.

The company financials for 2020 and 2021 are audited. The Company did not generate any revenue since it transitioned to its current business in 2022. However, a review of the Company's auditor reviewed financial statements for the 3-months ended September 30, 2022 (filed and disclosed on the OTC Marketplace online portal on November 15th, 2022) reflects that the Company reported revenues for third quarter of 2022 from its operations. The Company's financial statements are consistent with an operating business.

Based upon the business conducted by the Company in 2022, the Company hereby declares it has ceased to be a Shell Company under Rule 12b-2 and has remained a non-Shell Company since September 30, 2022
