## Change in Controlling Interest in Ayujoy Herbals Ltd.

On February 3, 2023, Ayujoy Holdings LLC. ("Ayujoy") closed a Share Transfer Agreement (the "Agreement") with Trimark Capital Partners Inc., a Canadian corporation ("Trimark"). Under the Agreement, Trimark acquired 40,656,200 shares of common stock in Ayujoy Herbals Ltd. from the former shareholder "Ayujoy". As result of these transactions, Trimark is our controlling shareholder. Ronald W. Loudoun is the principal of Trimark. Following the closing of the Agreement, we plan to continue with Ayujoy's business philosophy to make people's lives happier and healthier, but we will immediately seek the support of strategic partners to assist in achieving our growth aspirations as well as explore the option for direct investment and other potential financing alternatives. Further, we will seek to expand the Company's brand portfolio to support any potential for revenue growth and engage experts in advertising and digital marketing initiatives to improve sales and expand distribution.

## Appointment of New Officers and Director; Resignation of Former Officers and Directors

Immediately following the close of the Agreement, on February 3, 2023 Jeff Palumbo was appointed as Director to help lead the company going forward. The company has also accepted the resignations of both Ms. Suyogi Gessner and Ms. Shital Balser, directors of the company since August 2020.
