On July 25, 2023 Benjamin Berry signed a purchase agreement with Chong Hui Wan to sell the controlling interest in the company through 9,500,000 Series A Preferred Stock.

On July 27, 2023 as part of the transaction Chong Hui Wan was elected as Director, CEO, CFO and Secretary and Benjamin Berry resigned all positions with the company. The transaction closed and all documents were released from escrow on August 3, 2023.

2. The name(s) of person(s) who acquired control and person(s) from whom control was assumed. For corporations or other business entities, please provide the name(s) of person(s) beneficially owning or controlling such corporations or entities.²

Chong Hui Wan purchased the controlling Series A Preferred Stock from Benjamin Berry.

Benjamin Berry sold to Chong Hui Wan Nine Million Five Hundred Thousand (9,500,000) shares of Series A Preferred Stock of UMF Group Inc., which is convertible into Two Hundred Fifty (250) common shares of the Company per each Series A Preferred.

The consummation of a merger or consolidation of the Company with any other corporation, other than a merger or consolidation which would result in the voting securities of the Company outstanding immediately prior thereto continuing to represent (either by remaining outstanding or by being converted into voting securities of the surviving entity or its parent) at least fifty percent (50%) of the total voting power represented by the voting securities of the Company or such surviving entity or its parent outstanding immediately after such merger or consolidation.
