On March 20, 2024, Blackwell 3D Construction Corp. (the “Company”) filed a Regulation A Offering Statement under the Securities Act of 1933 (the “Act”) on Form 1-A (the “Offering Statement”), with the U.S. Securities & Exchange Commission (“SEC”). On April 24, 2024, the SEC issued a Notice of Qualification for the Company’s Offering Statement.
